Highlights From This Week

Executive Session Results

Executive Departments

HB 369 relative to the amortization of retirement system unfunded accrued liability—retained

HB 219 establishing a demographic study committee—still in committee

HB 413 relative to payment by the state of a portion of retirement system contributions of political subdivision employers—ITL 10-9

HB 425 relative to the retirement system assumed rate of return for the biennium beginning July 1, 2017—ITL 18-0

Municipal and County Government

HB 261 relative to background checks for county employees—delayed to next week

HB 108 relative to municipal record retention and conversion.—Amendment 2017-0081(corrects typos in the bill and changes the deciding factor to municipality and removes governing body—OTPA 14-1

Science Technology & Energy

HB 191 relative to the authority of towns to issue bonds for the expansion of Internet service—ITL 14-7

Hearings

HB 330- relative to form and rate filing fees.

Applies to insurance not the counties

Removed from tracking list

HB 272—relative to the election of county commissioners in Carroll county

Representative Butler introduced the bill

Most questions were about how counties elect commissioners now

Rep McCarthy testified in opposition to the bill

Presented a letter signed by 11 of 14 delegation members opposed to the bill

Presented a letter from Gene Chandler opposed to the bill

Argued that this was politically motivated

The committee was a bit difficult to read on this one. Most questions were technical questions.

HB 296— allowing counties to authorize and fund forensic audits.

Rep Cordelli introduced the bill

Stated delegations have the authority to get a performance audit but not a forensic one

Rehashed Carroll County's "missing money"

Many questions about what a forensic audit is and why they need it

Representative Belanger seemed to have the most difficulty with the language as written
Rep McCarthy spoke in support of the bill

This fixes the problem that the Commissioners have to spend appropriated funds

Overall I think the committee is skeptical about this bill and the need for a forensic audit vs a financial

HB 543— relative to part-time employment by a retiree for a retirement system employer.

Ray Bower and David Dione testified on behalf of the committee in opposition of the bill

NH Veterans Home, Substitute Teachers and several other testified against the bill as well.

The committee appeared sympathetic to our position and the important role that retirees can play

The retirement system stated that as the bill is written there is no way for them to enforce this

I think it is likely that this bill will be ITL

HB 442— relative to criminal records checks in the employee application process.

This is check the box legislation

Counties would fall under exemption (c) Any other position that requires automatic disqualification of
an applicant with a criminal history pursuant to federal or state law.

Several other organizations proposed the following exemption addition

(d) Any other position for which the employer is required by federal law or regulation to access
and use an individual's criminal history.

I think once these amendments are made the committee is likely to pass the bill

HB 476—relative to the duties of registers of probate.

This would restore the duties of probate back to the counties

Testimony was split and extensive

Speaking Against the bill were Judge King and Donna Sytek

Argued that this was a do nothing position that had no place in the court system and it would be
better to eliminate the position all together. Also stated that there have been no problems or
complaints since the courts took this over and it would be impossible to send this back to the
Counties

Speaking in Support of the bill were Rep Itse, Senator Gray, Bill Gardner, Jane Bradstreet

Argued that this was the right thing to do and that there are problems. The duties that probate has
retained are important and it is not a do nothing position. The courts have locked them out of
doing their jobs. They system we have now is unconstitutional.

This committee was recessed until next week.

CACR 8— relating to eliminating registers of probate. Providing that part II, article 71 be amended to
eliminate registers of probate.
